7. Grants – Paying the invoice for generators, so Katie will get those receipts submitted soon for the RIG grant. Still working on getting the water line project completed. No Action Needed.
8. Recent and/or Upcoming Events – School supplies have been delivered and ready to give to the students this week. Coy will contact the school board and superintendent on the handout day. August 23 will be the Water Fight for the kiddos with the First Responders. No Action Needed.
9. City Work Business – None
10. OPPRS Fee Increase – Matt wants to raise it from \$15 to \$20, so clerk will make an amended resolution to add the change and put on next month agenda. No Action Needed.
11. Police - Officer Burns is graduated and starting night shift. Matt got a bid on new PD Truck but would like to hold off due to the CPA issue and Budget. Coy said the budget has been approved for this Fiscal Year and a new unit was on it, so that won't change and told him to go ahead and order it. One officer still out on medical and having second surgery tomorrow, but probably be coming back on light duty due to PTO running out. No Action Needed.
12. Fire – Jeff shared things are running good, learning new recording system its not very user friendly but learning it and having couple others learn it also since this will be the only system allowed in the near future. Water Fight coming up. Driving training next month. No Action Needed.

13. New Business; Bay in the EMS building is getting to hot causing issues with the meds stored in the units, town will look at quotes for air conditioning unit but the bay doors will have to stay shut no more leaving the doors open often. No Action Needed.
14. Public Business; Jeff O. with the Savanna First Baptist church shared with council issues with the neighbor's trash and junk overflowing into the parsonage property. PD Chief stated that would be a civil matter, but he has been in contact with the owner asking to get it cleaned up because there is issues with the trash and junk being in the roadway causing issues for first responders also. Jeff shared the church is wanting to put up a fence but can't due to the overflow, so Matt said if the church will get the property surveyed then he will come and make sure the get it off the property line so a fence can be put up but it would still be a civil matter. That said the Matt will be taking photos and talking with the town attorney about sending letters, ordinances, etc. to get the property cleaned up. Jeff asked about a property on Brewer Road also, Matt agreed and said that is another one the town will be addressing as well.
