3. 7. Fire Business; Fire Chief Jeff Jones shared that many firefighters have been refreshed on training and dept. is doing well. No Action Needed

8. New Business- Coy discussed fixing more potholes throughout the town specially around the school and fixing water issues throughout in the coming months. Donut Shop is about 4 weeks or so out from being finished. Owners have started the progress of redoing the building on the highway to make it into a Hamburger Restaurant but we don't know the timeline yet.
